



MASTER ATHLETE DEVELOPMENT, LIABILITY, PAYMENT & PROTECTION AGREEMENT 2026/27

Registration, payment, electronic acknowledgment, form submission, facility entry for program purposes, or participation constitutes acceptance of this Agreement to the fullest extent permitted by New York law.

This Agreement is intended to clearly explain program expectations, payment rules, safety responsibilities, parent consent, and participation terms. Nothing in this document is intended to limit any rights that cannot legally be limited under New York law.

1. AGREEMENT SCOPE & PROTECTED PARTIES

This Agreement applies to all programs, training, camps, after-school sessions, academy activities, team events, facility use, tournaments, clinics, private sessions, homeschool/enrichment activities, recovery/wellness areas, classrooms, travel-related team activities, and related services operated, hosted, promoted, rented, controlled, or affiliated with Bogdan SKLZ, Salt City SKLZ Academy, Adventure at Burritt Sports, Adventure at Burritt Sports LLC, Bogdan SKLZ LLC, and any related or successor entity. Protected Parties include the entities listed above and their owners, founders, members, managers, coaches, staff, employees, contractors, volunteers, partners, affiliates, sponsors, landlords, facility owners, lessors, agents, representatives, insurers, and successors.

2. PROGRAM YEAR, TERM & SEASON REFERENCE

All references to the program year, season, academy year, registration year, or active agreement period refer to the 2026/27 operating cycle unless a separate written program document states otherwise. This Agreement may apply to programs beginning, continuing, or renewing during the 2026/27 cycle.

3. BINDING ACCEPTANCE WITHOUT PHYSICAL SIGNATURE

By registering online, submitting any form, downloading or acknowledging this Agreement, making full or partial payment, attending any session, allowing my child to participate, entering the facility for program purposes, or continuing participation after receiving this Agreement, I acknowledge and agree that I am fully accepting this Agreement on behalf of myself and my child. This Agreement is intended to be binding whether accepted electronically, physically, by payment, by registration, or by participation.

4. PARENT / GUARDIAN AUTHORITY

I confirm that I am the parent or legal guardian of the participating child, or that I have legal authority to enroll the child and accept this Agreement. I accept responsibility for communicating these terms to any other parent, guardian, caregiver, or family member involved with the child's participation.

5. ASSUMPTION OF RISK

I understand that soccer training, athletic development, camps, matches, scrimmages, strength and agility work, facility activity, travel, and related participation involve inherent risks, including but not limited to collisions, falls, sprains, fractures, concussions, overuse injuries, heat illness, dehydration, cardiac events, illness exposure, equipment contact, turf/court surface injuries, and accidental contact with other players. I voluntarily assume all inherent risks connected to my child's participation.

6. LIABILITY RELEASE - TO THE FULLEST EXTENT PERMITTED BY LAW

To the fullest extent permitted by New York law, I release and hold harmless the Protected Parties from claims arising out of ordinary risks of participation, athletic activity, program attendance, facility use, emergency response, or related events. Nothing in this Agreement is intended to waive rights or claims that cannot legally be waived under New York law.

7. INDEMNIFICATION

I agree to defend, indemnify, and hold harmless the Protected Parties from claims, demands, damages, disputes, losses, chargebacks, attorney fees, or expenses arising from my child's participation, my family's conduct, unpaid balances, violation of this Agreement, misuse of facilities, property damage, or actions by guests or family members connected to the participant.

8. MEDICAL CLEARANCE & EMERGENCY CARE

I confirm that my child is physically able and medically cleared to participate in intense athletic activity. I agree to notify staff in writing of any medical condition, allergy, injury, restriction, medication issue, or emergency concern. I authorize staff to seek emergency medical care when reasonably necessary, including EMS, urgent care, hospitalization, or emergency treatment. I accept full financial responsibility for all medical costs.

9. CONCUSSION / HEAD INJURY PROTOCOL

I understand that concussions and head injuries are serious. I agree to immediately report any known or suspected head injury, dizziness, headache, confusion, nausea, balance issue, vision issue, or other concussion-related symptom. If a concussion or head injury is suspected, the player may be removed from activity immediately and may not return until cleared by an appropriate medical professional, consistent with applicable law, safety standards, and program protocol.

10. DROP-OFF, PICK-UP & SUPERVISION BOUNDARIES

Parents/guardians are responsible for timely drop-off and pick-up. Staff supervision applies only during scheduled program activity and reasonable transition periods as determined by the program. Parents/guardians remain responsible for any child before check-in, after dismissal, in parking areas, outside designated program spaces, or when the child leaves staff-supervised areas without permission.

11. MEDIA / PHOTO / VIDEO RELEASE

I grant Bogdan SKLZ, Salt City SKLZ Academy, Adventure at Burritt Sports, and their affiliates permission to photograph, record, film, livestream, post, edit, and use my child's image, likeness, voice, athletic performance, name, team participation, and training footage for marketing, social media, websites, promotional materials, player development, internal review, parent communication, sponsorship materials, and academy documentation. No compensation or further approval is required.

12. DATA, PERFORMANCE & DEVELOPMENT CONSENT

I consent to the collection, storage, review, and use of my child's athletic, technical, tactical, physical, attendance, behavioral, leadership, academic/enrichment, and performance-related data for development purposes. This may include testing, video analysis, progress tracking, internal coach notes, Individual Player Development Plans, quarterly reports, parent updates, team placement decisions, and academy improvement.

NO REFUND / PAYMENT POLICY

ALL PAYMENTS ARE FINAL AND NON-REFUNDABLE once the parent/guardian acknowledges this Agreement, signs this Agreement, submits online registration, makes payment, or allows the child to participate - whichever occurs first. There is no first-week refund window. Any previous refund language is replaced by this clause unless a specific written exception is issued by an authorized representative of Bogdan SKLZ / Salt City SKLZ Academy / Adventure at Burritt Sports. Missed sessions may be made up only within the active package period, subject to schedule availability, program rules, staffing, space, and coach approval. Makeups are a courtesy, not a guaranteed cash credit. Chargebacks, payment disputes, unpaid balances, or failed payments may result in immediate suspension from all programs, teams, camps, academy activities, and facility access until resolved.

13. MISSED SESSIONS, CLOSURES & SCHEDULE CHANGES

Program schedules, staffing, field availability, facility access, weather, safety decisions, tournament needs, and operational requirements may require changes, substitutions, rescheduling, relocation, or cancellations. The program may offer reasonable makeups, credits, alternate sessions, or schedule adjustments at its discretion, but schedule changes do not create a cash refund right unless expressly stated in writing by an authorized representative.

14. NO GUARANTEE OF TEAM PLACEMENT OR RESULTS

Training payment does not guarantee team placement, playing time, roster selection, tournament selection, position, scholarship opportunities, college recruitment, or competitive advancement. Selection is based on measurable performance, attitude, commitment, attendance, coachability, positional need, team chemistry, readiness, and staff evaluation.

15. PARENT & PLAYER CODE OF CONDUCT

Parents and players agree to support a professional academy culture. This includes respect for coaches, staff, teammates, opponents, referees, families, facilities, and program decisions. Parents may not interfere with training, coach from the sideline, create conflict with other families, undermine staff decisions, pressure coaches for placement, or damage the culture of the academy. Players are expected to show effort, discipline, respect, punctuality, coachability, humility, and commitment. Violations may result in restricted access, team removal, training suspension, or dismissal from the program without refund.

16. COMMUNICATION EXPECTATIONS

Parents/guardians agree to communicate respectfully and through approved program channels. Urgent safety or medical concerns should be communicated immediately. Playing time, placement, roster, and pathway questions should be handled through appropriate parent meetings or staff-approved communication times, not during active sessions, games, or staff supervision periods.

17. INTELLECTUAL PROPERTY & DEVELOPMENT SYSTEM PROTECTION

All drills, progressions, coaching language, training curriculum, performance systems, mental strength protocols, leadership methods, data models, player reports, 7-Pillar development model, onboarding system, tactical concepts, camp structure, academy structure, homeschool/enrichment integration, and internal documents are proprietary to Bogdan SKLZ, Salt City SKLZ Academy, and Adventure at Burritt Sports. Parents, players, staff, contractors, competitors, clubs, and outside organizations may not copy, reproduce, teach, sell, distribute, record for commercial use, share, or reverse-engineer these systems without written permission. Violation may result in immediate removal and legal action.

18. PRIMARY DEVELOPMENT COMMITMENT

Players enrolled in the core or elite pathway acknowledge Bogdan SKLZ / Salt City SKLZ Academy / Adventure at Burritt Sports as their primary technical and tactical development environment. School teams, recreational play, and outside events may be permitted. Participation with other competitive clubs or conflicting development programs should be disclosed and may require written approval where it affects the player's Individual Player Development Plan, team commitment, schedule, or academy pathway.

19. ONBOARDING PROTOCOL

New players may complete a structured onboarding period lasting approximately 4-12 weeks. This may include baseline testing, culture integration, scrimmage evaluation, technical review, tactical assessment, physical benchmarks, parent communication, and creation of an Individual Player Development Plan. Team placement is earned. It is never automatic.

20. INDIVIDUAL PLAYER DEVELOPMENT PLAN

Players may receive a living, data-backed Individual Player Development Plan covering technical, tactical, physical, mental, leadership, character, academic/life integration, and performance areas. Plans may be reviewed quarterly or periodically based on program level, attendance, staff capacity, and athlete commitment.

This Agreement applies at all locations used by Bogdan SKLZ, Salt City SKLZ Academy, Adventure at Burritt Sports, and affiliated programs, including but not limited to Syracuse, Oswego, Watertown, Sackets Harbor, camps, rented facilities, school facilities, partner facilities, outdoor fields, indoor fields, gyms, courts, turf areas, classrooms, wellness/recovery areas, parking areas, and event spaces. Participants and families must follow all facility rules. Damage to property, unsafe behavior, unauthorized access, misuse of equipment, or failure to follow staff instructions may result in removal without refund and financial responsibility for damages.

22. PERSONAL PROPERTY, EQUIPMENT & BELONGINGS

Participants and families are responsible for personal belongings, equipment, uniforms, electronics, valuables, water bottles, bags, and other items brought to any program or facility. Protected Parties are not responsible for lost, stolen, damaged, or misplaced personal property except where responsibility cannot legally be disclaimed.

23. SEVERABILITY & GOVERNING LAW

If any portion of this Agreement is found unenforceable, the remaining sections remain valid and enforceable to the fullest extent permitted by law. This Agreement is governed by the laws of the State of New York.
